**Sub:** Regarding bringing to the notice of all the students about all the Notices / Letters / Circulars related to the Secondary School Certificate Examination and Higher Secondary School Certificate Examination

According to the above mentioned subject, it is being informed to the Heads of all the recognized Secondary Schools and Junior Colleges under the Mumbai Divisional Board that all the recognized Secondary Schools / Junior Colleges are always being informed by the Board by regularly sending appropriate circulars regarding the Revised Syllabus and Question-Paper Pattern of Std. 9<sup>th</sup> & 10<sup>th</sup>, and the Syllabus and it's Extension and Limitations, Practical Planning and Scheme and Changes / Corrections made in the Textbook - Units of Std. 11<sup>th</sup> & 12<sup>th</sup>. However, the Board has received complaints that students don't get any notice regarding these Circulars or these Circulars never reach them.

The above mentioned Circulars and other Circulars sent by the Board related to the Notice for filling up Application Forms, Corrections regarding Admission Forms, Provisions available for Handicapped Students and Government Resolutions regarding the same, Prescribed Form, Grade Improvement Schemes, Applications of the Students from Sports category, etc. don't come to the notice of all the students or this information doesn't reach them. Therefore, you are being informed that you should inform all the students about the Circulars which will be sent henceforth by the Board. These Circulars have also been made available on the website.

Information sent by the Board time and again through Notices, Letters and Circulars, should be brought to the notice of the parents and the students by conducting parent-meetings at your respective levels, and their signatures on the

respective documents should be filed in the School's / Junior College's office. Also, note that, henceforth, if the Board receives any complaint from the students / parents or if any legal matter takes place regarding the same, then the respective School / Junior College will be responsible for the same.
